Produce Industry lags behind in Number of Comments Submitted to Mexican Trucking Pilot Program as deadline looms

During the week of April 25th, the NPC hosted its annual State Managers meeting in Washington DC. During that event, there was a meeting held with Karen Antebi, Trade & NAFTA Office, Ministry of Economy - Embassy of Mexico, regarding the Department of Transportation's pilot program to allow Mexican domiciled trucks into the US. In that meeting, it was discovered that the teamsters have submitted over 100 negative comments on the DOT pilot program. We are now in desperate need of your help to provide positive comments for the program. Many of the State and National organizations including NPC, IPC and IGSA have already submitted comments.

Currently the docket has registered 152 comments:

- Background 9
- Positive 24
- Negative 118
- Neutral 1

It is imperative that we do our part to change these numbers. Please share your views with DOT; The comment deadline is May 13, we urge you to take action on this matter.
