## Government Affairs Report By Pat Kole

### Seed Potato Import Protocol Agreement for Thailand

USPB, together with NPC, IPC and other state commissions including the OPC and WSPC, are pleased to announce that an agreement has been reached with Thailand for importing seed potatoes. Here is the announcement from John Toaspern from USPB:

Seed Exporters, please find attached the just signed seed potato import protocol for Thailand. This agreement took a number of years but we have achieved equivalency with the other exporters to the market. Unfortunately, the Thais insist on visiting every state to be included under the agreement, so it only covers the 4 states they visited this summer. We will have them return next spring or summer to visit additional US seed producing states. We will also be working with the other exporters to the market to convince the Thais that some of their virus tolerances are below international standards. We felt it was better to get what we could now and pursue a better and broader agreement down the road. There is strong interest in Thailand for chip-stock seed potatoes, so we envision this agreement resulting in good sales in the coming years. Please let us know if you have any questions. ### Amplify Post Harvest Treatment, by John Keeling, NPC

We have had several calls from growers about the current status of the post harvest treatment Amplify (DIPN). This week I met with EPA to discuss the use Amplify and the current regulatory status of the product. Amplify has been

available for post harvest use based on a conditional registration for six years. That conditional registration lapsed on August 1, 2009. Based on what I learned, Amplify that is currently packaged, labeled and in the market can be used by growers this season. At the same time the conditional registration lapsed, the tolerance established for Amplify also lapsed. The registrant is currently seeking a new registration for the product and has filed a petition to reestablish the tolerance. The petition for tolerance is an expedited process and assuming that the data filed by the registrant checks out the tolerance would be in place quickly. I know that the registrant has submitted the necessary studies requested by EPA and I have every reason to believe that the data supports establishing a tolerance to support the continued use of the product.
