This week in the Idaho legislature will center around budget issues, and also consideration of bills introduced earlier this session. Most observers don't see many dramatic changes taking place due to the budget uncertainty. On the federal level, four Idahoans are participating in the NPC/USPB leadership program. Last week they were in Oregon looking at processing plants and packing facilities. This year's participants are: Travis Blacker, Jared Gehring, Nora Olsen, and Eric Whalen.

# Industry Relations Report By Todd Cornelison

News from the Idaho AgSummit:

#### Idaho Power adds a new buyback program.

In an effort to make its power buyback programs more attractive to growers, Idaho Power has added a new "dispatch able" program. While the company still offers the "timer" program, where growers pick how many days a week they will allow a shutdown, the dispatch-able program allows the grower more options. Under this program, the power company attaches wireless controllers to the pumps so they can be shut down electronically. This allows the company to tailor the shutdowns for its power needs, in turn, allowing them to pay more for the power. Here are a few of the highlights of the new program:

- The dispatch able program covers the same time period June 1<sup>st</sup> through July 31<sup>st</sup>.
- The dispatch able program offers higher incentives to the grower, and is available at no cost to the grower down to a 50 hp pump. The program is available on smaller hp motors but at the grower's cost.
- Under this program, the grower allows shut downs between 2:00 8:00 pm on weekdays, for no more than
  4 hours a day and 15 hours a week. There are no shutdowns on July 4th.
- The maximum amount of shutdown hours for the season is 60.
- The customer is contacted by 4:00 pm the day prior to the shutdown and has the opportunity to deny a shutdown.
- The customer is contacted 30 minutes prior to an agreed upon shutdown.
- The customer can opt out 5 times during a season.
- For growers that have the ability to take part in these programs, their power cost can be reduced by 70-80% during the program period, which calculates to an approximate 38% reduction in their annual power costs.
